NOTICE TO STOCKHOLDERS AMENDMENT TO 2020 ANNUAL MEETING INFORMATION STATEMENT

The 2020 AgFirst Farm Credit Bank Annual Meeting Information Statement ("AMIS") was mailed to all stockholders on June 8, 2020. Subsequent to the mailing, the AgFirst Farm Credit Bank ("AgFirst") Nominating Committee revised the slate of nominees for the 2021-2022 Nominating Committee election. The 2020 AgFirst Election Calendar was also revised to allow sufficient time for stockholder notification. There were no changes to the 2020 Director Election Slate.

2020 Director Election

Under the Bylaws of AgFirst Farm Credit Bank (“AgFirst”), the following Board seat is open for election:

- One (1) Regional Seat in Region Three

AgFirst is strictly prohibited from distributing campaign material. The candidate information provided herein is for regulatory and educational purposes only.

Nominations

The candidate is identified on **Exhibit A**, attached to this Annual Meeting Information Statement, together with disclosure/biographical information for the candidate.

- **Nominating Committee** - The nominee(s) for the open director position have been selected by the 2019/2020 AgFirst Farm Credit Bank Nominating Committee (**Amended Exhibit B**). Please note there is only one candidate for the Region Three, Regional Seat. The Nominating Committee and the workgroup of the full Nominating Committee (consisting of committee members from the respective election region) conducted searches for at least two nominees for the open seat. The workgroup coordinated with the regional Association Boards and their chairmen, as well as their management in an effort to identify two candidates for the open seat. Inquiries were made of particular individuals regarding their potential interest in being a candidate or their knowledge of other potential candidates. These inquiries were in addition to the interviews with the Board and management soliciting interested nominees. However, the Nominating Committee was unable to identify two qualified and willing candidates for the open seat. The Nominating Committee’s efforts to locate two qualified and willing candidates for the open seat were reported to the AgFirst Board of Directors (“Board”).
- **Other Nominations** - AgFirst bylaw and election procedures allow for additional stockholder nominations from April 28, 2020 to May 22, 2020. No additional stockholder nominations were received. Nominations will not be accepted from the floor for director candidates.

Nominating Committee Election

Nominees for the 2021/2022 Nominating Committee will be presented for election during 2020 for two-year terms. The slate of candidates, as submitted by the Nominating Committee, for members and alternates is attached hereto as **Amended Exhibit C**. Ballots will be mailed simultaneous with ballots for the director position. The Bank, as Administrator of Elections, facilitates the nomination process for candidates for the Nominating Committee recommended by the

voting stockholders and submits such names for nomination to the Nominating Committee. Nominations for the Nominating Committee will not be accepted from the floor. All voting stockholders will vote for all seats on the Nominating Committee on a weighted basis. Voting for Nominating Committee members and alternates shall be noncumulative. Voting stockholders may vote for the entire slate or for individual nominees or alternates. Please refer to the **Amended Exhibit C** for a listing of candidates for the 2021/2022 AgFirst Farm Credit Bank Nominating Committee.

Stockholder Voting Rights

Voting for the director position and nominating committee positions will be held by mail ballot. Please refer to the amended dates below.

- Director Election - Ballots and candidate disclosures for the director election will be mailed on or before August 14, 2020.
- Nominating Committee Election – Ballots for the nominating committee election will be mailed on or before August 14, 2020.
- Ballots for the director election and the nominating committee election must be received by Elliott Davis no later than noon on October 15, 2020.

All eligible AgFirst voting stockholders as of April 30, 2020 (the “Amended Record Date”), are entitled to vote for the stockholder-elected director position and the Nominating Committee positions. Each voting stockholder has one vote that shall be assigned a weight proportional to the number of that Association’s voting stockholders as of the Amended Record Date. For the director election, stockholders shall be allowed to cumulate such votes and distribute them in the stockholders’ discretion.

Voting Stockholders

As of the Amended Record Date, the number of AgFirst voting stockholders entitled to vote is nineteen. The weighted vote of each voting stockholder is set forth on the attached **Amended Exhibit D**.

Director Candidate Forum

Due to the cancellation of the 2020 Annual Meeting, the director candidate interview forum will not be held. The candidate may be available for individual stockholder interviews. Any interviews should be arranged with the individual candidate and the respective Associations at their sole discretion.

Disclosure Information

Employee, director, and director candidate loans, and loans to their immediate family members and any organizations with which employees, directors, and the director candidate are affiliated were made on the same terms, including interest rate, amortization schedule, and collateral, as those prevailing at the time for comparable transactions with other persons, and did not involve more than the normal risk of collectability. In addition, all disclosure statements required of director candidates pursuant to AgFirst bylaws/policies and FCA regulations shall be mailed with election ballots to the voting stockholders.

Mailing Date and Online Availability of Amended Annual Meeting Information Statement

The Amended 2020 Annual Meeting Information Statement was mailed to all stockholders on July 31, 2020, and it was published on AgFirst's website (www.agfirst.com) simultaneous with its mailing. It will be available on AgFirst's website for at least thirty days. Copies of the Amended 2020 Annual Meeting Information Statement are also available for inspection at AgFirst Farm Credit Bank, 1901 Main Street, Columbia, South Carolina 29201.

Annual Report

The 2019 Annual Report was made available to stockholders for viewing on AgFirst's website (www.agfirst.com) when the report was submitted to the Farm Credit Administration within 75 days of year end. Board of Directors (Currently Serving)

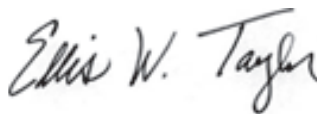
